- 18) The school shall make arrangements for medical examination of students every year.
- 19) The management shall deposit in the joint name of B.E.O and Managements as security deposit.

1. Student's admission and attendance shall be as per rules.
2. The instruction shall not open any additional sections without premonition from the government or the department.
3. As per Karnataka Education Act-3 and G.O. No ED. 131/vivida /98, Bangalore dated 04-11-1999 shall deposit Rs. 30000 in the joint name in the national banks as security deposit.
4. The school shall provide Furnitures, Library, Playground, building and sports material as per Karnataka Education act 1983 within 6 months.
5. The school shall make arrangement for medical examination of students every year.
6. All accounts of the school be audited by an authorized auditor every year.
7. The school be recognised for further five years within two months of the opening of the school.
8. Every year the school be audited.

9. The school shall collect only the fee prescribed by the department. No donations be collected.
10. School shall use the text books prescribed by the department.
11. 50% of the students must be present in schools run by schedule caste / schedule tribe schools.
12. The school should get renewal of recognition one year after the first recognition.
13. Service security be given to the teachers of Unaided schools and the salary of the teachers should not be less than the minimum basic pay of the scale as per 2012 pay scales.
14. Salary of the teachers be disbursed through bank only.
15. The service register of the teachers be opened immediately.
16. Admissions to be made as per child education Act.
17. Fire extinguisher be installed in school.
18. In the radius of hundred meters from the school the sale of tobacco products should be prohibited.
19. Safety measures for children to be taken as per the circular issued by the commissioner, DPI Bangalore vide letter No. C7 (4) Pra. Shi. Aa/ Sha-Ma-Li -Ki/ 40/2014-15 dated 20-11-2014
20. Safety measures for school vehicles to be taken as per the letter No. Sa-Aa/Pravartana -3/ PR/197/2005-06 dated 22-11-2014.

The school management has to satisfied above conditions as per Education act-39 within one year failing which the recognition will be cancelled

Sub:- Amendment in affiliation Bye-laws Rule 3.3(I) chapter II-reg.

Sir/Madam,

Consequent upon recommendations of the Affiliation Committee made in its meeting held on 24.06.2013 and subsequently approval of the Governing Body of the Board in its meeting held on 28.06.2013, the following amendment in affiliation Bye-laws of the Board has been made by the Board:

Existing Rule 3.3 (I) chapter II	Amended Rule 3.3 (I) chapter II
The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T. Govt. Its application either should be forwarded by the State Govt. or there should be a No Objection Certificate to the effect that State Government has no objection to the affiliation of the school with the CBSE. "No Objection Certificate" once issued to any school will be considered at par even if it prescribes a specific period of *stage unless it is withdrawn. Condition of submitting a No Objection Certificate will not be applicable to categories 3.1(i) to (iv)	The school seeking provisional affiliation with the Board must have formal prior recognition of the State/U.T Govt. and also to produce evidence to this effect that the applicant school had intimated to the concerned Education Department of the State about the application made to CBSE for seeking affiliation with the Board. In case, the Board receives any objection during the process of application of the school, the Board may ask the concerned school to produce the No Objection Certificate from the State Government or otherwise it would be assumed that concerned State/U.T. Government has No objection.

The above amendment is brought to the notice of all concerned.
